

# **TANGLED IN TOYS'**

## **Disney Pixar Toy Giveaway**

### **Terms and Conditions and Official Rules for the giveaway:**

In order to be eligible for the *Tangled in Toys* Disney Pixar Toy Giveaway, contestants must do the following 3 things:

1. Subscribe to our YouTube channel (*Tangled in Toys*)
2. Like the Disney Pixar Toy Giveaway – Incredibles 2, Cars & Toy Story Woody video
3. Leave a comment in the comment section of the video telling us which one of the toys you like the best

The giveaway runs from 11:59 A.M. PST [Pacific Standard Time] on Saturday, June 16, 2018 to 11:59 P.M. PST [23:59 PST] on Sunday, June 24, 2018. Once the giveaway closes, no late entries will be included in the drawing. The giveaway is open to all viewers, 18 years old and up, who reside in an unsanctioned country by the United States. If viewer is under 18 years old, then he/she must get parent/guardian consent before participating.

There will only be one winner of the giveaway that will be randomly selected out of the users who have completed the 3 steps mentioned above. Entries that don't comply with the steps above will not be eligible to win. The winner will be announced on our website ([www.tangledintoys.com](http://www.tangledintoys.com)) and we will also pin a comment at the top of the comment section in the video to list the winner at 5:00 P.M. PST [17:00 PST] on June 25, 2018.

The winner will have 48 hours to contact *Tangled in Toys* to claim the prize. We may be contacted directly through YouTube or by filling out the contact form on our website (<http://www.tangledintoys.com/contact.html>).

If the selected winner does not claim the prize within 48 hours, we will select another winner and he/she will be notified in the same manner as stated above.
