Coronavirus Stinks! Toy Giveaway

Terms and Conditions and Official Rules for the giveaway:

In order to be eligible for the *Tangled in Toys* Coronavirus Stinks! Toy Giveaway, contestants must do the following 2 things:

1. Follow us on Instagram (@tangledintoys)

2. On Instagram, leave a comment on our post with the number of jellybeans that you think are in the jar.

The giveaway runs from 9:00 P.M. PST [Pacific Standard Time] on Saturday, April 18, 2020 to 11:59 P.M. PST [23:59 PST] on Sunday, May 3, 2020. Once the giveaway closes, no late entries will be included in the drawing. The giveaway is open to all viewers, 18 years old and up, who reside in the United States. If viewer is under 18 years old, then he/she must get parent/guardian consent before participating.

There will only be one winner of the giveaway that will be selected based on the number of jellybeans guessed.
